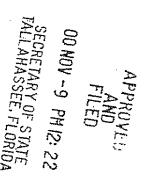

ARTICLES OF ORGANIZATION OF

RIECK LAND COMPANY, L.L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is:

ARTICLE II

Address

Duration

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the written consent of the remaining members.
