# ARTICLES OF ORGANIZATION

OF

## MR-GAS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the limited liability company shall be **MR-GAS, L.L.C.**, ("Company").

### ARTICLE 2 - ADDRESS

The general purpose for which the Company is organized is to engage in the sale of refrigerant gas and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.


