ARTICLES OF ORGANIZATION

OF

NEUROSURGEONS.CC, LLC

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

<u>ARTICLE I - NAME</u>

The name of this limited liability company shall be Neurosurgeons.cc, LLC (the "Company").

ARTICLE II - DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III - PURPOSE

The purpose of the Company is to engage in any lawful business activity that is not prohibited

with respect to a limited liability company organized according to the laws of the State of Florida.
