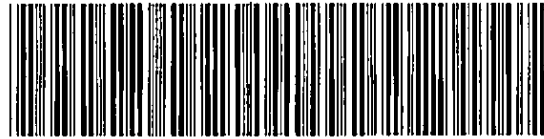

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, CAC REAL ESTATE, LLC, a Florida limited liability company (the "Company"), whose Articles of Organization were filed with the Florida Department of State on November 15, 2000 under Document No. 1.00000014060, adopts the following amendment to its Articles of Organization.

Article IV of the Company's Articles of Organization is deleted in its entirety and replaced with the following new Article IV:

**ARTICLE IV
MANAGEMENT**
