ARTICLES OF ORGANIZATION FOR RU READY, L.L.C.

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (together herein referred to as the "Members") acting as the organizers and the Members of RU Ready, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Fla_Stat_, adopt the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is RU Ready, L.L.C.

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law.
