The mailing address and street address of the Company is 5020 Bentgrass Circle, Ponte Vedra Beach, Florida 32082.

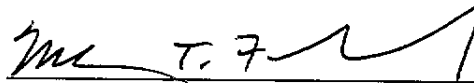
**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**

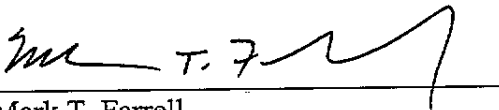
