ARTICLES OF ORGANIZATION OF A  
FLORIDA LIMITED LIABILITY COMPANY

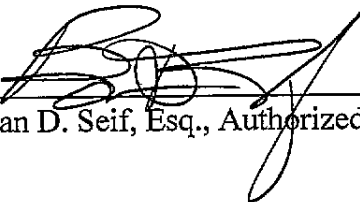

IN WITNESS WHEREOF, the undersigned has executed these Articles of Organization this 16<sup>th</sup> day of November, 2000.

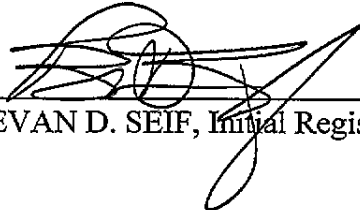
