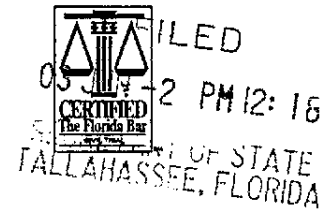



ARTICLE VI – PENDING LAWSUITS




