# ARTICLES OF ORGANIZATION OF FURMAN CLARK CONSTRUCTION, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act. F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be Furman Clark Construction, L.L.C. ("Company"). The principal place of business of the Company in Florida shall be 319 Centre Street, Fernandina Beach, Florida 32034. The mailing address is the same.

## **ARTICLE II - DURATION**
