ARTICLES OF AMENDMENT

TO

ARTICLES OF ORGANIZATION

OF

LIGHTHOUSE VIEW, LLC

FIRST: The date of filing of the articles of organization was November 16, 2000.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

(a) Article VII of the Articles of Organization is deleted and the following new Article VII is substituted in its place to read as follows:

"ARTICLE VII PROFITS AND LOSSES

(a) <u>Profit Sharing</u>. The member shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. The member shall be entitled to the distributive share of profits as follows:


(1) to GLT TRUST: 100%

The distributive share of the profits shall be determined and paid to the member each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being the date of filing of the original Articles of Organization with the Florida Secretary of State.

added to the Articles of Organization to read as follows:
