ARTICLES OF ORGANIZATION OF JUTTRIS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company shall be JUTTRIS, L.L.C.

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the company shall be: 644 North Lake Way, Palm Beach, Florida, 33480.

ARTICLE III DURATION
