## THIRD AMENDMENT TO AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CREEKSIDE MANAGEMENT, L.L.C.

The following is being executed and filed pursuant to Florida Statute 605.0202as a third amendment to the Amended and Restated Articles of Organization of Creekside Management, L.L.C., which were originally filed with the Florida Department of State on November 21, 2000 and amended by Amended and Restated Articles of Organization filed on November 30, 2000 (as amended, the "Articles of Organization"). The following amendments were adopted by the Limited Liability Company and shall supersede and replace all provisions contained in the Articles of Organization.

1. Article II is hereby deleted in its entirety and replaced with the following:

"The principal place of business mailing address is: 2450 Hollywood Blvd., Suite 602, Hollywood, Florida 33020"

2. Article V is hereby amended by inserting the following at the end thereof:

"So long as the loan (the "Loan") in the amount of \$65,000,000 to be secured by a mortgage (as the same may be amended or otherwise modified from time to time, the "Mortgage") in favor of Jefferies LoanCore LLC (together with its successors and assigns, "Lender") remains outstanding, no member may resign and no new member may be admitted to the Limited Liability Company without the prior written consent of Lender."

- 3. Article VIII is hereby deleted in its entirety.
- 4. Article X is hereby deleted in its entirety and replaced with the following:

"The Limited Liability Company shall, at all times while the Loan is outstanding, (x) comply with Article IX and the other SPE Provisions (as such term is defined in the Operating Agreement in effect on the date hereof) of the Operating Agreement of the Limited Liability Company in effect on the date hereof, (y) cause the Partnership to comply with Article XIV and the other SPE Provisions (as such term is defined in the Limited Partnership Agreement in effect on the date hereof) of the Limited Partnership Agreement as in effect on the date hereof, and (z) comply with all of the assumptions made in the non-consolidation opinion delivered by Dilworth Paxson, LLP to the holder of the Mortgage in connection with the Loan."

5. The foregoing amendment was adopted by all members and managers on August  $\mathcal{M}$ , 2015.
