ARTICLE I

NAME

The name of this limited liability company is Berk of Sarasota, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

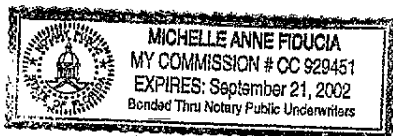

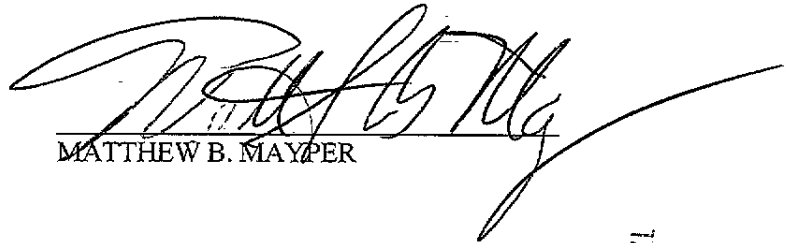
