## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF TAMPA BAY CHAMPIONSHIP RODEO, LLC

WHEREAS, the Articles of Organization of Tampa Bay Championship Rodeo, LLC were filed with and approved by the Secretary of State of the State of Florida on the 27<sup>th</sup> day of November, 2000;

WHEREAS, it is the intention of the sole member that the Articles of Organization of Tampa Bay Championship Rodeo, LLC be amended and restated in accordance with the proposed amendment and restatement hereinafter set forth;

WHEREAS, the proposed amendment and restatement was duly executed and filed in accordance with Section 608.411, Florida Statutes;

WHEREAS, the proposed amendment and restatement hereinafter set forth was approved by the sole member on December 18, 2003; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment and restatement hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Organization of Tampa Bay Championship Rodeo, LLC are hereby amended by amending and restating in its entirety the present entire Articles of Organization and by substituting therefore the following, to-wit:

# "AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF TAMPA BAY CHAMPIONSHIP RODEO, LLC

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Organization for the purpose of forming a limited liability company solely not-for-profit in accordance with the laws of the State of Florida.

#### ARTICLE I NAME

The name of this limited liability company shall be:

#### ARTICLE II ORGANIZATION

This limited liability company is organized according to Florida limited liability company laws and are enforceable at law and in equity.

## ARTICLE II MANAGEMENT

The limited liability company is a member-managed company.

## ARTICLE III PURPOSE

- (a) The general nature, objects and purpose for which this limited liability company is exclusively organized and operated for exempt purposes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and is operated exclusively to further the charitable purposes of it's member.
- (b) This limited liability company will not carry on activities not permitted to be carried on by an organization described in Code Section 501(c)(3), all as more specifically set forth in the Operating Agreement of the Company.
- (c) In the event of dissolution or final liquidation of the limited liability company, all assets remaining after the payment of liabilities shall be distributed exclusively to one or more organizations themselves that are exempt as organizations or are organized for exempt purposes under Code Section 501(c)(3) or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, state or local government for exclusive public purpose.
- (d) In the event of a merger, this limited liability company is hereby prohibited from merging with, or converting into, a for-profit entity at any time.

## ARTICLE IV DISTRIBUTIONS AND TRANSFERS

- 4.1 The membership interest of the Company may only be issued and/or transferred to a transferred that is a Code Section 501(c)(3) organization or governmental unit for instrumentality. Any direct or indirect issuance or transfer to any transferred that is not a Code Section 501(c)(3) organization is strictly prohibited.
- 4.2 In the event one or more members ceases at any time to be an organization described in Code Section 501(c)(3) or a governmental unit or instrumentality, a distribution of the assets of the nonexempt member(s) may be transferred according to the following provisions:
  - (i) The nonexempt member's interest must be forfeited; or

(ii) A forced transfer of the nonexempt organization's interest to another Code Section 501(c)(3) organization or governmental unit or instrumentality.

A distribution of the assets to the nonexempt member(s) is prohibited and upon transfer the nonexempt member's rights in the limited liability company are fully terminated within ninety (90) days from the date the member's exemption is revoked.

- 4.3 The assets, other than membership interest, of this limited liability company may only be transferred to a transferree that is a Code Section 501(c)(3) organization or governmental unit or instrumentality in exchange for fair market value. Any direct or indirect transfer to any transferree that is not a Code Section 501(c)(3) organization or ceases to be a Code Section 501(c)(3) organization is strictly prohibited.
- 4.4 The exempt Member(s) of the Company will expeditiously and vigorously enforce all of their rights in the Company and will pursue all legal and equitable remedies to protect their interest in the Company.

## ARTICLE V AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended only if consistent with Code Section 501(c)(3) and as provided in the Operating Agreement.

#### ARTICLE VI REGISTERED OFFICE AND REGISTERED AGENT

The street address of the limited liability company's registered office is 9633 Handcart Road, Dade City, Florida 33525 and the name of the limited liability company's registered agent at such address is Thomas N. Lange. The limited liability company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Florida Statutes.

IN WITNESS WHEREOF, this Amendment and Restatement of Articles of Organization is hereby executed on behalf of Tampa Bay Championship Rodeo, LLC by the Authorized Representative of its Member this day of April, 2004.
