# ARTICLES OF ORGANIZATION OF ELERO, L.L.C.

1. The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

Remaining members of this Company shall have the right to continue the business of the company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any event that terminates the continual membership of a member in the limited liability company, upon the vote of at least sixty-six percent (66%) of the remaining members.
