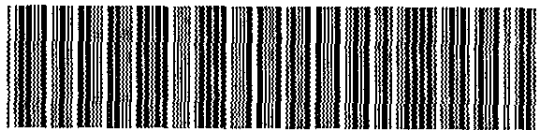

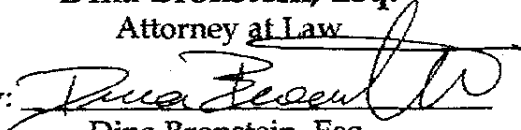

**ARTICLES OF ORGANIZATION**

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapters 607 and 621, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 – NAME**

The name of the limited liability company shall be **INOTEC, L.L.C.**, ("Company")

**ARTICLE 2 – ADDRESS**

## **ARTICLE 9 – TERMINATION OF EXISTENCE**

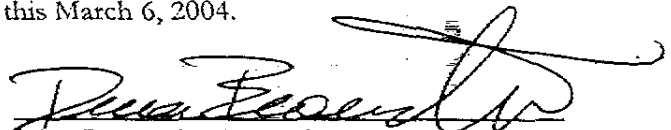
