WHEREAS, the Articles of Organization contain an incorrect statement.


THEREFORE, the undersigned files these Articles of Correction pursuant to §608.4115, Florida Statutes, and states as follows:

1. The Articles of Organization for NexGen Management, LLC contained the following incorrect statement: In Article I and in item 1 of the Certificate of Designation of Registered Agent/Registered Office (the "Certificate") attached as page 4 of the Articles of Organization, the name of the LLC was incorrectly stated.
2. Therefore, Article I of the Articles of Organization and item one of the Certificate attached to the Articles of Organization for NexGen Management, LLC are corrected in their entirety to read as follows:

"The name of the limited liability company ("Company") is NexGen Marketing, LLC."

3. The Secretary of State is hereby requested to approve and file these Articles of Correction in accordance with Section 608.4115, Florida Statutes, to be effective retroactive to the effective date of the Articles of Organization.
