ARTICLES OF ORGANIZATION

The undersigned, an authorized person for the purpose of forming a limited liability company under the provisions and subject to the requirements of the Florida Limited Liability Company Act, Fla. Stat. §608.401 through §608.514, and the acts amendatory thereof and supplemental thereto (the "Act"), hereby certifies that:

FIRST. The name of the limited liability company (the "LLC") formed hereby is "JLC Suncoast-Harbinger Properties, L.L.C."
