**ARTICLES OF ORGANIZATION
FOR FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE - I - Name

The name of the limited liability company shall be:
Barnhill, Barnhill, & Barnhill L.L.C.

ARTICLE II - Address

The mailing address and street address of the principal office of the limited liability company is:


ARTICLE VI - Right to Continue Business

On the death, retirement, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VII - Profits and Losses

(a) Profit Sharing. The members shall be entitled to net profits arising from the operation of the limited liability company business that remain after the payments of expenses for conducting the business of the limited liability company. Each member shall be entitled to an equal distributed share of profits.

(b) Losses. All losses that occur in the operation of the limited liability company shall be paid out of the capital of the limited liability company and profits of the business or, if these sources are insufficient to cover such losses, by the members in equal shares.
