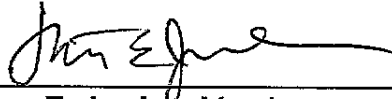

Management**

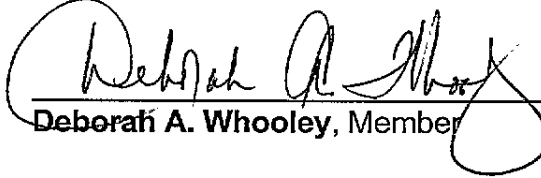
The Limited Liability Company shall be managed by its Members and is, therefore, a member-managed company.
