ARTICLES OF ORGANIZATION
OF
INTERMEX WIRE TRANSFER SERVICES, LLC

The undersigned do hereby adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act.

FIRST: The name of the limited liability company is INTERMEX WIRE TRANSFER SERVICES, LLC.

SECOND: The mailing address and street address of the principal office of the limited liability company is 11060 North Kendall Drive, Miami, Florida 33176.

THIRD: The name and street address of the initial registered agent for service of process in Florida is 11060 N. Kendall Drive, Miami, Fla., 33176.

FOURTH: The limited liability company is to be managed by John B. Rincon, one of its members, and is to be a manager-managed company. The manager has been designated, appointed and elected by the approval or consent of all the members executing these Articles. The manager is expressly empowered to sell or transfer a portion of his membership interest pursuant to two agreements of even date herewith, one between the limited liability company and Cesar Rincon, and the other between the limited liability company and Carlos Rincon, which agreements have been made known to all of the members of the limited liability company and if and when such agreements are effective, Cesar Rincon and/or Carlos Rincon, as the case may be, shall become members of the limited liability company.

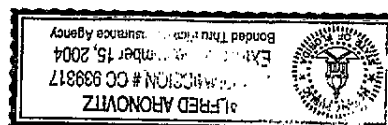

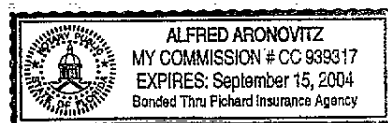
