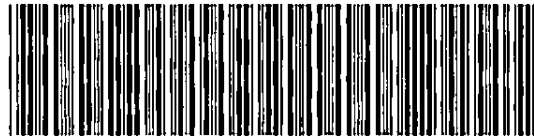

FIRST: The date of filing of the Articles of Organization was December 7, 2000.


SECOND: Articles of Amendment to the Articles of Organization were adopted by the limited liability company on August 11, 2003.

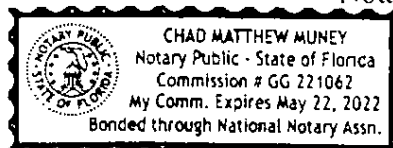

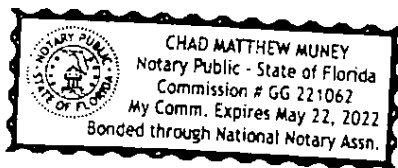
