ARTICLES OF ORGANIZATION

OF

ST. JOE DEERWOOD PARK, L.L.C.

Pursuant to the requirements set forth within §608.407 of the Florida Limited Liability Company Act, the undersigned, being a natural person, does hereby act as the authorized representative in adopting and filing the following articles of organization for the purpose of organizing a limited liability company.

ARTICLE I - NAME

The name of the limited liability company (hereinafter referred to as the "Company") shall be **St. Joe Deerwood Park, L.L.C.**

ARTICLE II - DURATION


