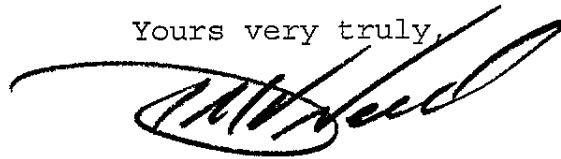

ARTICLE V - MANAGEMENT

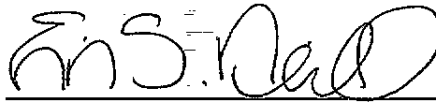
The company shall be a member-managed company in accordance with regulations adopted by the members for the management of the

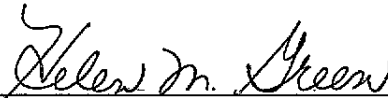
