The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VIII - PROFITS AND LOSSES

Net profits and net losses shall be allocated to the members of the company proportionally in relation to the total capital contribution of each such member.

The company shall be managed by a manager or managers in accordance with an operating agreement or regulations adopted by the members for the management of the business and affairs of the company. This operating agreement or these regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. The manager need not be a member of the company.


