**ARTICLES OF ORGANIZATION  
OF  
CORNERSTONE MEDICAL CARE OF BRANDON, P.L.**

1. Name. The name of this limited liability company is CORNERSTONE MEDICAL CARE OF BRANDON, P.L., a Florida professional limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles of Organization with the Florida Department of State, unless these Articles of Organization or the operating agreement of the Company provides otherwise.

3. Purpose. The Company is organized for the purpose of rendering medical services and transacting all lawful activities and businesses that may be conducted by a professional limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 500 Vonderberg Drive, East Tower, Suite 101, Brandon, Florida 33511.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Joseph W.N. Rugg. The street address of the initial registered agent of the Company is 100 S. Ashley Drive, Suite 1500, Tampa, Florida 33602.

6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by the members. No additional contributions have been agreed upon.

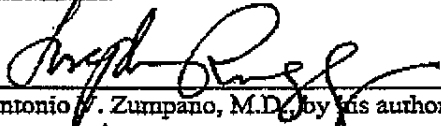
7. Initial Members. The initial members of the Company shall be Antonio V. Zumpano, M.D. and Julio A. Enriquez, M.D.

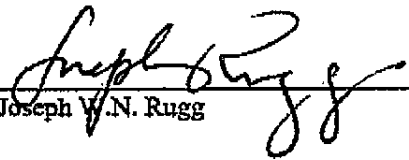
