

THIRD: The Articles of Organization are further amended to provide that all references to "Manager" or "Managers" shall mean the Managing Member or Managing Members, as the case may be.


FOURTH: The effective date of these Articles of Amendment shall be the date of filing with the Florida Department of State.

FIFTH: The remainder of the Articles of Organization are unchanged and shall remain in full force and effect.


