**ARTICLES OF ORGANIZATION OF

The undersigned, Lorraine D. Esser, a natural person competent to contract and member of this limited liability company, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

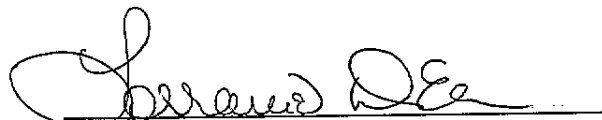
