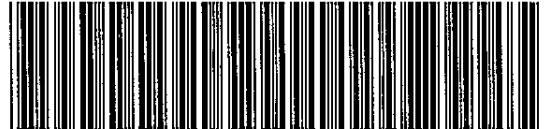

A FLORIDA LIMITED LIABILITY COMPANY**

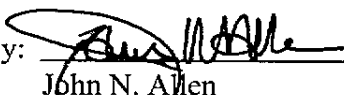
The Articles of Organization of J.E.D./ALLEN OF S.W. FLORIDA, L.L.C., are hereby amended in the following respects:
