ARTICLES OF ORGANIZATION

The undersigned natural person of the age of eighteen (18) years or more, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE ONE



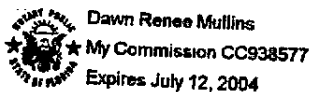
