Termination of Existence

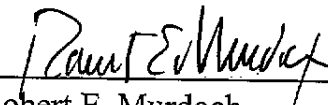

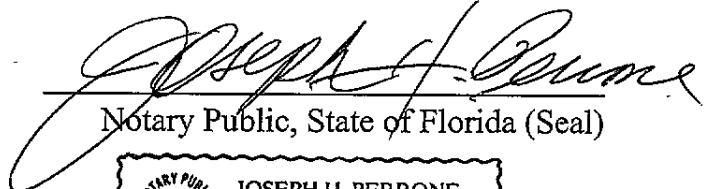
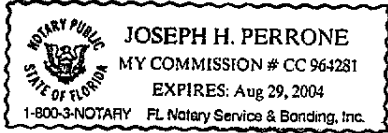
