ARTICLES OF ORGANIZATION

FOR

D.T.T. PROPERTIES, LLC

A Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 608, Florida Statutes, the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such Company

ARTICLE I Name

The name of this Company shall be D.T.T. PROPERTIES, LLC.

ARTICLE II <u>Duration</u>

The term of existence of the Company shall commence December 31, 2000 and shalf perpetual.

ARTICLE III Mailing Address

ARTICLE IV Registered Agent and Office

In the event a new Member is added by such amendment, it shall be also signed by the Member to be added.
