**ARTICLES OF ORGANIZATION OF  
HEALTHCARE RESEARCH & DEVELOPMENT INSTITUTE, L.L.C.**

The undersigned, GAIL L. **ARTICLE I - NAME**

The name of the limited liability company is:

**ARTICLE VI - MANAGEMENT**

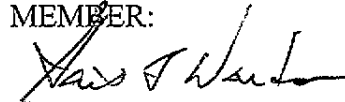
The Company shall be a manager-managed company, managed by managers designated as a Board of Directors.
