HEALTHCARE RESEARCH & DEVELOPMENT INSTITUTE, L.L.C., a Florida limited liability company (the "LLC"), files these Articles of Dissolution evidencing the LLC's dissolution and discontinuation of business, and sets forth the following pursuant to the provisions of Section 608.445, Florida Statutes:

1. The name of the LLC is HEALTHCARE RESEARCH & DEVELOPMENT INSTITUTE, L.L.C.
2. The Articles of Organization of the LLC were filed on December 20, 2000 and assigned document number L00000015783.
3. The dissolution was approved by the Members of the LLC on December 21, 2006.
4. Pursuant to Section 608.441(1)(b), Florida Statutes, the occurrence of the event that resulted in the dissolution of the LLC was the vote of the members of the LLC to discontinue the operations of the LLC and to dissolve the LLC in accordance with the terms of the Operating Agreement of the LLC.
5. All debts, obligations and liabilities of the LLC have been paid or discharged.
6. Any remaining property and assets of the LLC have been distributed among its members in accordance with their respective rights and interests.
7. There are no suits pending against the LLC in any court.

The undersigned Members of the LLC, representing the percentage of membership interests necessary to approve the dissolution, have executed these Articles of Dissolution in accordance with the provisions of Section 608.408, Florida Statutes.
