ARTICLES OF ORGANIZATION

OF

ATOCHA/MARGARITA EXPEDITION - 2001, LLC (a Florida Limited Liability Company)

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is Atocha/Margarita Expedition - 2001, LLC. The Company's street address and mailing address is 200 Greene Street, Key West FL 33040.

ARTICLE II

Commencement and Duration of Company

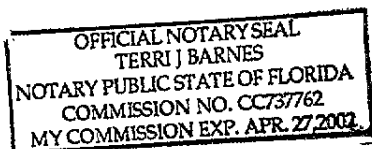
