**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 605, Florida Statutes, the Articles of Organization of **BAMBOO MOBILE HOME PARK, LLC**, a Florida limited liability company (the "Company") which were filed with the Secretary of State for the State of Florida on December 21, 2000, are hereby amended as follows:

1. Article 7 of the Articles of Organization of the Company is amended to read:

Articles 7, 10 and 11, contained within the Amended and Restated Articles of Organization of the Company, which was filed with the Division of Corporations, State of Florida on June 4, 2009, are hereby declared to be withdrawn from the Articles of Organization of the Company and shall be of no further force or effect.

4. The foregoing amendments were adopted by the unanimous approval of the Members of the Company on May 20, 2014.


