The undersigned Incorporator has executed these Articles of Organization on this 13 day of December, 2000.

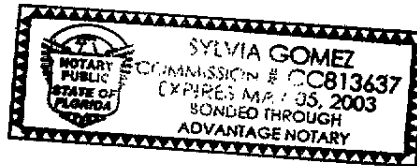
