**ARTICLES OF ORGANIZATION
OF
BHG PROPERTIES, LLC**

1. Name. The name of this limited liability company is BHG PROPERTIES, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist commencing on December 21, 2000, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing address and the street address of the Company's principal office is 2814 West Virginia Ave., Tampa, Florida 33607.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Albert P. Silva. The street address of the initial registered agent of the Company is 201 N. Franklin Street, Suite 2200, Tampa, Florida 33602.

6. Management of the Company. The management of the Company is reserved to its members and is, therefore, a member-managed company.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

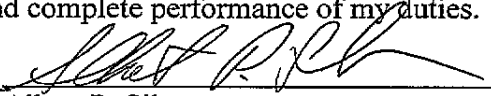
