**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
LONG PETROLEUM PRODUCTS, LLC**

The undersigned, for the purpose of amending the Articles of Organization of LONG PETROLEUM PRODUCTS, LLC, a Florida limited liability company, hereby makes acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

FIRST: The Articles of Organization of LONG PETROLEUM PRODUCTS, LLC, were filed with the Florida Department of State on December 21, 2000, and were assigned Document Number L0000005889.

SECOND: The following amendment to the Articles of Organization was adopted by LONG PETROLEUM PRODUCTS, LLC: Article V is hereby deleted in its entirety and replaced as follows:

The Company shall be managed by a Manager(s) in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. A member of the Company may serve as the Manager. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
