ARTICLES OF ORGANIZATION OF MAESTO ASSOCIATES L.L.C.

The undersigned, for purposes of forming a limited liability company in accordance with the Florida Limited Liability Company Act, do hereby state the following:

- NAME. The name of the limited liability company shall be MAESTO ASSOCIATES L.L.C. (the "Company").
- DURATION. The period of the Company's duration is perpetual from the date of filing the
 Articles of Organization with the Florida Secretary of State, unless sooner dissolved by the
