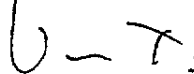

This limited liability company shall commence December 21, 2000.

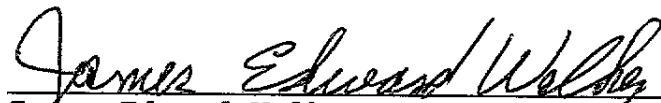
Article III - Principal Office and Mailing Address

Article IV - Initial Registered Office and Agent

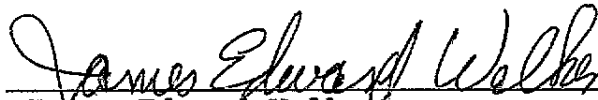

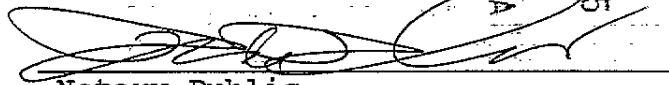
