**ARTICLES OF ORGANIZATION  
OF  
C&C Logistics, L.L.C.**

The undersigned subscriber to these Articles of Organization, a natural person competent to contract hereby forms a Limited Liability Company under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the Limited Liability Company shall be:

**ARTICLE II. TERM OF EXISTENCE**

**ARTICLE VII. ADMISSION OF ADDITIONAL MEMBERS**

Additional member(s) may be admitted to the Limited Liability Company upon an affirmative vote of (80%) percent of the existing members of the Limited Liability Company. Each existing member is entitled to one vote.

**ARTICLE VIII. MEMBERS RIGHT TO CONTINUE BUSINESS**

Upon the death, retirement, resignation, expulsion, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Limited Liability Company, the remaining member(s) shall have the right to continue the business of the Limited Liability Company. Within sixty (60) days of termination of membership of a member, a final distribution of the earnings and profits, appreciation, and the capital account attributable to the departing member shall be made to the Departing member pursuant to the terms and conditions of the Regulations.

**ARTICLE IX. LIMITATION OF LIABILITY**

Each member, manager, and officer, in consideration for his services, shall, in the absence of fraud, be indemnified, whether then in the office or not, for the reasonable cost and expenses incurred by him in connection with the defense of, or for advise concerning any claim asserted or proceeding brought against him by reason of him being or having been a manager, member or officer of the Limited Liability Company or any subsidiary of the Limited Liability Company, whether or not wholly owned, to the maximum extent permitted by law. The foregoing right of the indemnification shall be inclusive of all other rights to which any member, manager or officer may be entitled as a matter of law.

**ARTICLE X. SELF DEALING**

No contract or any other transaction between the Limited Liability Company and any other entity, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the members or managers of the Limited Liability Company is or are interested in a contract or transaction, or are members, managers, partners, directors, or officers of any other entity. Any members, managers, or officers, individually or jointly, may be a party or parties to, or may be interested in such contract, act or transaction, or in any way connected with

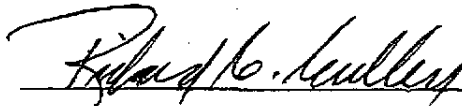

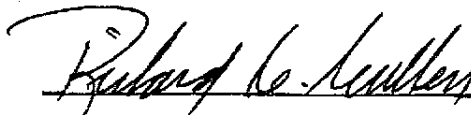
