#### ARTICLES OF ORGANIZATION

# BATES HOLDINGS, LLC, a Florida limited liability company

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

#### **ARTICLE ONE - NAME**

The name of the limited liability company shall be BATES HOLDINGS, LLC (the "Company").

#### ARTICLE TWO - COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles of Organization are accepted and filed with the Florida Department of State and shall continue until terminated in accordance with the Operating Agreement of the Company.

#### ARTICLE THREE -MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE

## ARTICLE FIVE - PURPOSES AND GENERAL POWERS

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

#### ARTICLE SIX - MANAGEMENT

The Company shall be a manager-managed company. The Company shall be maraged by at least one (1) manager. The number of managers may be increased as provided in the Operating Agreement of the Company.

# ARTICLE EIGHT - ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which may corrain any provisions for the regulation and management of the business and affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608 of the Florida Statutes.

## ARTICLE NINE - HEADINGS AND CAPTIONS

The headings or captions of these various Articles of Organization are inserted for correnience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
