**ARTICLE III - DURATION**

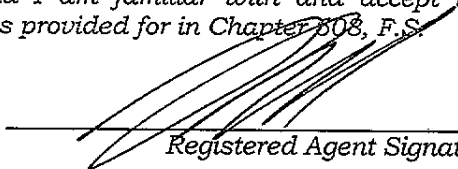

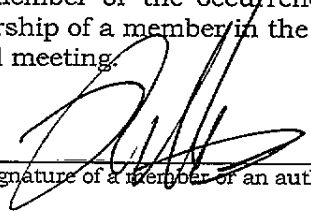

## ARTICLE VII - MEMBERS RIGHT TO CONTINUE BUSINESS

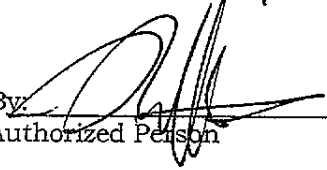
