Article III

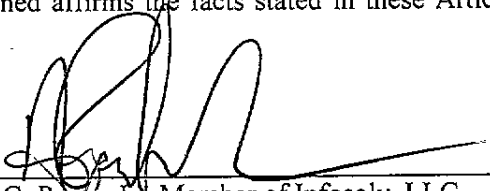
The Company is to be managed by member.
