ARTICLE I - NAME:

ARTICLE V - ADMISSION OF NEW MEMBERS

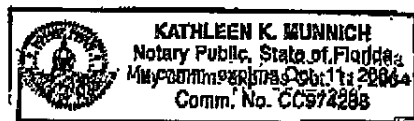
