

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

PARAMOUNT MILLER GRAPHICS, INC. (DOCUMENT NUMBER: L00054)



The name of the corporation is PARAMOUNT MILLER GRAPHICS, INC., a Florida corporation (the "Corporation") and its document number is L00054. The Articles of Incorporation of the Corporation as heretofore granted by the Secretary of State of the State of Florida on July 6, 1989, as thereafter amended, are hereby further amended in the following particulars:

1. Section 4.1 of Article IV of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"Article IV CAPITAL
