The name of the corporation is PARAMOUNT MILLER GRAPHICS, INC., a Florida corporation (the "Corporation") and its document number is L00054. The Articles of Incorporation of the Corporation as heretofore granted by the Secretary of State of the State of Florida on July 6, 1989, as thereafter amended, are hereby further amended in the following particulars:

1. Section 4.1 of Article IV of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"Article IV  
CAPITAL

Section 4.1 Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one hundred fifty thousand (150,000) shares of voting common stock having a par value of \$.10 per share."

The proposed amendment of the Articles of Incorporation as set forth in Paragraph 1 hereinabove was approved effective as of March 28, 2003, by unanimous written consent of the directors of the Corporation and further approved effective as of March 28, 2003, by the written consent of a majority of the shareholders of the Corporation owning the voting stock of the Corporation. The number of votes cast by such voting group was sufficient for approval by that voting group.
