FIFTH: These Articles of Dissolution will take effect upon filing.

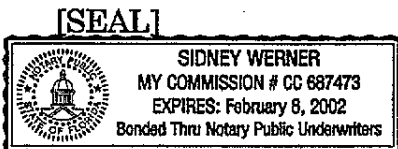

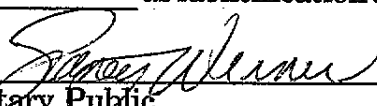
