I would like to petition the State of Florida to wave the reinstatement penalty for my company, Corporate Printing Management Services, Inc. for the following reason:

On May 1, 1999 I closed my business (Corporate Printing Co., Inc., 6202 Benjamin Rd., Suite 312, Tampa, FL 33634) and merged my customers and some equipment with Alliance Printing & Graphics, 4701 110th Avenue North, Clearwater, FL. and I had my mail forwarded to that address. Things did not work out with Alliance and I was terminated in November 1999, I then restarted my business as a printing brokerage and rented a temporary office at 14502 N. Dale Mabry, Suite 200, Tampa, FL 33618 in January 2000. In June 2000 I found a permanent office at 4137 W. Waters Avenue, Tampa, FL 33614.

Because of the merger I could not afford to purchase printing equipment therefore I started the brokerage business and changed the name to Corporate Printing Management Services, Inc. I then found out that my company had been dissolved for not filing the Annual Report. I can only apologize and say that with all the problems and moving around we never received the documents and therefore did not file the paperwork needed to keep our corporation in good standing. Our current business is just getting off the ground and is still a very small business (2 people), \$900.00 is a large sum of money for us right now.

Thank you for your consideration in this matter. Enclosed is a check for \$300.00 for the current year's Annual Report.
